Complaint Language I am informed by ____ [WITNESS], of an address known to the District Attorney's Office, that he observed defendant Renzo Gracie approach ____ [CW 1] and tackle him to ground. I am further informed by ____ [WITNESS] that he then observed defendants Andre Gusmao, Leonardo Leite, Igor Gracie, and three other separately charged defendants (Leonardo Dacosta; Gregor Rangel; and Rafael Barbosa Carvalho Da Costa), approach and begin executing roundhouse kicks and other martial arts maneuvers against other individuals who were attempting to intervene and pull defendant Renzo Gracie off of ____ [CW 1].

I am informed by ____ [CW 1], of an address known to the District Attorney's Office, that he is an employee of 1 OAK, at the above location, and that he observed defendant Renzo Gracie grab him about the body and throw his body to the ground, causing him to land on his right arm. I am further informed by ____ [CW 1] that defendant Renzo Gracie was joined by defendants Andrew Gusmao, Leonardo Leite, Igor Gracie, and three other separately charged defendants (Leonardo Dacosta; Gregor Rangel; and Rafael Barbosa Carvalho Da Costa), and that the seven men proceeded to swing at and attempt to kick security personnel from the location who were attempting to come to his aid. I am further informed by ____ [CW 1], that as a result of the above described events, he was in substantial pain to his arm and that he suffered a broken elbow.

I am informed by ____ [CW 2], of an address known to the District Attorney's Office, that he observed defendant Renzo Gracie approach ____ [CW 1] and tackle him to ground. I am further informed by ____ [CW 2] that he then observed at least six other men executing roundhouse kicks and other martial arts maneuvers against other individuals who were attempting to intervene and pull defendant Renzo Gracie off of ____ [CW 1]. I am further informed by ____ [CW 2] that one of the men began choking ____ [CW 2] by grabbing his tie and pulling, and that as a result of the ensuing struggle, ____ [CW 2] suffered substantial pain to his left knee and right shin.
