CRIMINAL COMPLAINT

The Defendant above named having committed the crimes of BATTERY WITH SUBSTANTIAL BODILY HARM (Category C Felony - NRS 200.481 - NOC 50214); BATTERY BY STRANGULATION (Category C Felony - NRS 200.481 - NOC 54735); BATTERY RESULTING IN SUBSTANTIAL BODILY HARM CONSTITUTING DOMESTIC VIOLENCE (Category C Felony - NRS 200.481; 200.485; 33.018 - NOC 57937); OPEN OR GROSS LEWDNESS (Gross Misdemeanor - NRS 201.210 - NOC 50971); ASSAULT WITH A DEADLY WEAPON (Category B Felony - NRS 200.471 - NOC 50201) and COERCION (Category B Felony - NRS 207.190 - NOC 53159), in the manner following, to-wit: That the said Defendant, on or about the 8th day of August, 2014, at and within the County of Clark, State of Nevada,

COUNT 1 - BATTERY WITH SUBSTANTIAL BODILY HARM

did then and there wilfully, unlawfully, and feloniously use force or violence upon the person of another, to-wit: COREY THOMAS, by repeatedly punching the said COREY THOMAS in the face, resulting in substantial bodily harm to the said COREY THOMAS.

COUNT 2 - BATTERY BY STRANGULATION

did then and there willfully, unlawfully, and feloniously use force or violence upon the person of another, to-wit: COREY THOMAS, by strangulation.

COUNT 3 - BATTERY RESULTING IN SUBSTANTIAL BODILY HARM CONSTITUTING DOMESTIC VIOLENCE

did then and there wilfully, unlawfully, and feloniously use force or violence upon the

7 COUNT 4 - BATTERY RESULTING IN SUBSTANTIAL BODILY HARM

9 did then and there wilfully, unlawfully, and feloniously use force or violence upon the
10 person of his spouse, former spouse, or any other person to whom he is related by blood or
11 marriage, a person with whom he is or was actually residing, a person with whom he has had
12 or is having a dating relationship, a person with whom he has a child in common, the minor
13 child of any of those persons or his minor child, to-wit: CHRISTINE MACKINDAY, by
14 kicking the said CHRISTINE MACKINDAY in the rib cage, resulting in substantial bodily
15 harm to the said CHRISTINE MACKINDAY.

16 COUNT 5 - OPEN OR GROSS LEWDNESS

17 did then and there wilfully and unlawfully commit an act of open or gross lewdness by
18 licking his finger and rubbing CHRISTINE MACKINDAY'S genital area.

19 COUNT 6 - ASSAULT WITH A DEADLY WEAPON


20 did then and there wilfully, unlawfully, feloniously and intentionally place another
21 person in reasonable apprehension of immediate bodily harm and/or did willfully and
22 unlawfully attempt to use physical force against another person, to-wit: CHRISTINE
23 MACKINDAY, with use of a deadly weapon, to-wit: a knife, by holding said knife to the said
24 CHRISTINE MACKINDAY'S head.

25 COUNT 7 - COERCION

26 did then and there wilfully, unlawfully, and feloniously use physical force, or the
27 immediate threat of such force, against CHRISTINE MACKINDAY, with intent to compel
28 her to do, or abstain from doing, an act which she had a right to do, or abstain from doing, by

1 forcing the said CHRISTINE MACKINDAY to take a shower.

2 All of which is contrary to the form, force and effect of Statutes in such cases made and
3 provided and against the peace and dignity of the State of Nevada. Said Complainant makes
4 this declaration subject to the penalty of perjury.
