FINE PAYMENT PLAN AGREEMENT

Date: November 30, 2016

Contestant: Nick Diaz

On January 12, 2016, the Nevada State Athletic Commission ("Commission") accepted a settlement agreement ("Settlement Agreement") in a disciplinary matter involving Contestant Nick Diaz ("Diaz"), under which Diaz was ordered to pay a monetary fine of \$100,000 ("fine"). As of the date of this payment plan agreement, the balance remaining on the above referenced fine is \$75,000.

Pursuant to section 1.3 of the Settlement Agreement, Diaz hereby enters into a payment plan with the Commission to pay off the \$75,000 balance of the fine under the following terms:

- 1) Except as otherwise provided in paragraph 2 below, Diaz shall make minimum monthly payments of \$1,000 each to the Commission. Said payments shall be due and payable on the last day of each month commencing on December 31, 2016, until the balance of the fine is paid in full. Attached is the payment schedule based on the minimum required monthly payment. (See Attachment 1.)
- 2) Notwithstanding the forgoing provision, if Diaz competes in a contest or exhibition in Nevada or in any other jurisdiction prior to paying the balance of his fine, Diaz shall, within 90 days of said contest or exhibition, pay the Commission a monetary sum equal to the entire outstanding balance of the fine levied by the Commission.

- 3) Pursuant to Section 1.4 of the Settlement Agreement, Diaz agrees to provide the Commission with negative tests results of his urine for all prohibited substances, both incompetition and out-of-competition as designated by the WADA Prohibited List, 30, 15 and 3 days before his next contest in Nevada. Diaz further agrees that he will file his application for an unarmed combatant's license at least 30 days before his next contest in Nevada should he chose to again participate in any unarmed combatant contests or events held within the State of Nevada.
- 4) If Diaz remains current under this payment plan, and complies with the other requirements set forth herein and in the Settlement Agreement, he will be eligible to apply for an unarmed combatant's license to participate in unarmed combatant contest and events held within the State of Nevada.
- 5) If Diaz fails to comply with the terms of this payment plan, the Executive Director may institute a new disciplinary action against Diaz.
